- DataQuest, Dashboard, Local
- Review the data – achievement, graduation and college/career readiness, attendance, discipline, mobility
- What does the data show for foster youth/vulnerable youth?

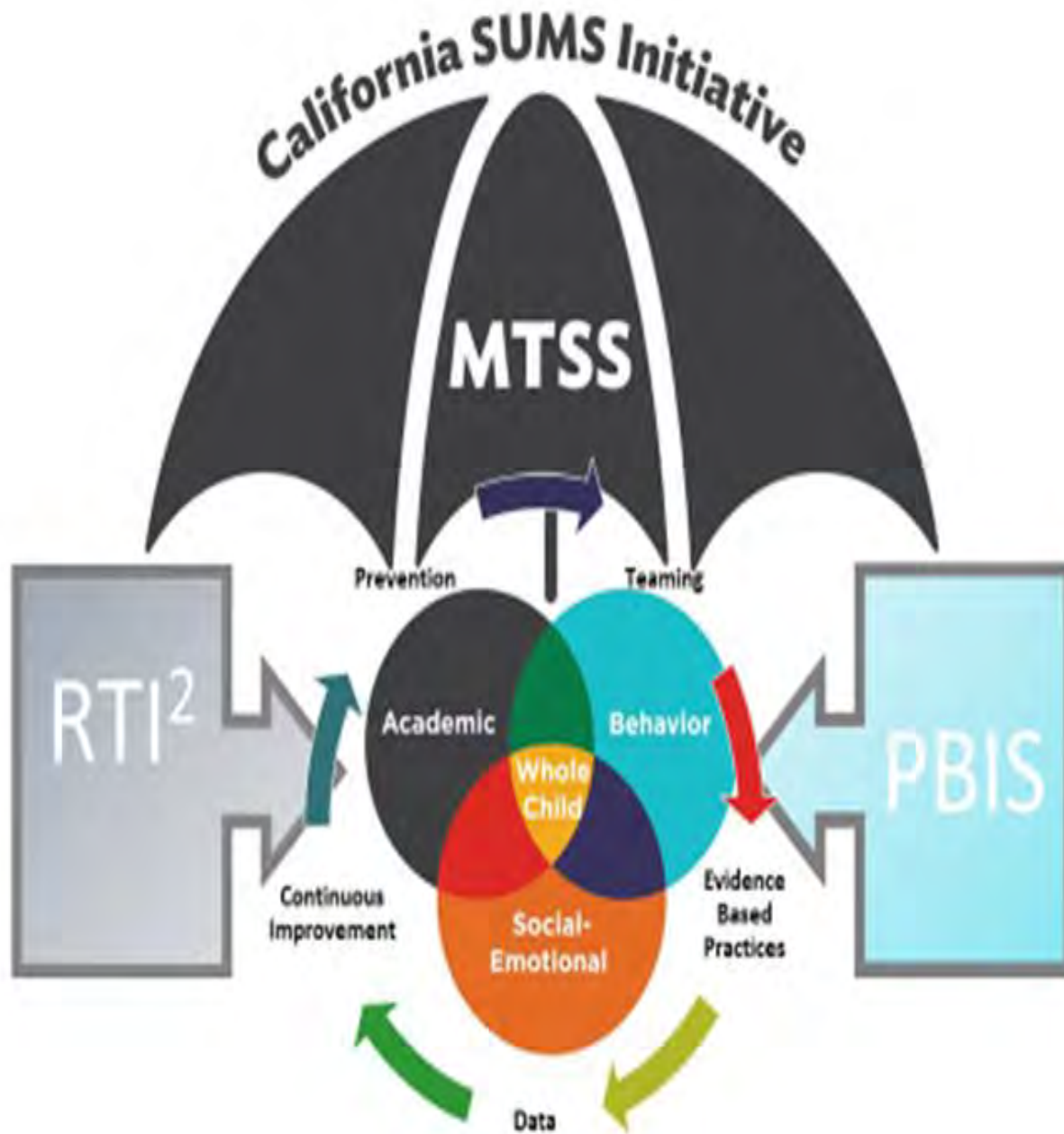

- Provide comprehensive behavioral and socio-emotional supports
- Integrated Educational Framework
  - Identify who has access – all means all 😊
  - Strong and Positive School Culture
    - Foster collaborative relationships
- Family and Community Engagement
  - Engagement
  - Communication
- Trusting Community Partnerships
  - Engagement
  - Mutual interests and goals



# Strategies to Support Foster Youth

# STRATEGIES TO SUPPORT FOSTER YOUTH



## SCHOOL COMMUNITY

Ensure someone meets with and orients each foster youth for success.  
Explore additional services for youth to experience opportunities including extracurricular activities.



## TEAMING

Allow for strong team communication and coordination of services between the caregiver, social worker/probation officer, education rights holder, mental health provider, school and student.  
Invite team members to school meetings and communicate successes as well as challenges.



## RELATIONSHIP

Develop a mentoring program and foster youth clubs on campus.  
Support and promote positive relationships between youth, peers, and staff.



## ACCESS

Develop a process so the student/caregiver is taking advantage and aware of school supports.  
Ensure that the student has space to complete homework and access to internet away from school.



## TRAUMA INFORMED

Implement practices that enhance school climate and allow youth to feel safe at school.  
Provide staff development on understanding the impact of trauma on the youth's behavior, development, learning, and relationships.



## EMPOWERMENT

Communicate and advocate to ensure the school/district is supporting the youth.  
Ensure educational rights holder can access academic and behavioral supports for the student.



## GRADUATION

Develop a system to ensure each foster youth has a graduation, college and/or career transition plan.  
Provide support to help foster youth complete post-secondary resources: FAFSA, California College Promise Grant, Chafee Grant, and scholarships.



## ISSUE SPOTTING

Have quarterly check-ins for issue spotting and communication.  
Connect youth to early intervention services discovered from issue spotting.



## ENGAGE YOUTH VOICE

Allow time and space for students to communicate their needs at school.  
Ensure youth's voice is heard during meetings and follow-up with youth after meetings.

# School Community



- Ensure someone meets with and orients each foster youth for success.
  - Counselor, Foster Youth Liaison, Administrator, who else?
- Explore additional services for youth to experience opportunities including extracurricular activities.
  - Have the student write a one page introduction. What are their strengths, interests, goals?

# Teaming



- Allow for strong team communication and coordination of services between the caregiver, social worker/probation officer, education rights holder, mental health provider, school and student.
  - Who can lead teaming efforts at school site?
- Invite team members to school meetings and communicate successes as well as challenges.
  - If team member cannot be present, how is their perspective being included?



# Relationship



- Develop a mentoring program and foster youth clubs on campus.
  - How can we help youth feel connected to others?
- Support and promote positive relationships between youth, peers, and staff
  - Research shows that One Caring Adult can make all of the difference.

# Access



- Develop a process so the student/caregiver is taking advantage and aware of school supports.
  - MTSS, Foster Youth Liaison, McKinley-Vento, Special Education
- Ensure that the student has space to complete homework and access to internet away from school.
  - What barriers at home is the school not aware of?

# Trauma Informed



- Implement practices that enhance school climate and allow youth to feel safe at school.
  - How can we maximize the students sense of safety?
- Provide staff development on understanding the impact of trauma on the youth's behavior, development, learning, and relationships.
  - Who needs to be trained? Who has capacity to lead?

# Empowerment



- Communicate and advocate to ensure the school/district is supporting the youth.
  - Is the youth participating in any tier 2 or 3 interventions?
- Ensure educational rights holder can access academic and behavioral supports for the student.
  - Access to academic counselor, online parent portal, school and district resources.

# Graduation



- Develop a system to ensure each foster youth has a graduation, college and/or career transition plan.
  - Is there already a system in place that can be enhanced?
- Provide support to help foster youth complete post-secondary resources: FAFSA, California College Promise Grant, Chafee Grant, and scholarships.
  - Resource packet

# Issue Spotting



- Have quarterly check-ins for issue spotting and communication.
  - Are there inconsistencies with behavior or academic performance?
- Connect youth to early intervention services discovered from issue spotting.
  - Tiers of support, check in, check out, social emotional group, individual counseling, ect.

# Engage Youth Voice and Stakeholder



- Allow time and space for students to communicate their needs at school.
- Ensure youth's voice is heard during meetings and follow-up with youth after meetings.
- Encourage foster youth participation on LCAP planning teams and stakeholder groups.
- Promote discussions supporting foster youth to ensure the system is supporting their unique needs.
